Annual Message from the PCI Board

We are very sad to report the recent passing of our President Cynthia Quarta and our immediate Past-President Loretta Doran Day (see below). Our Board is reeling with grief. It is difficult to go on without them, but we know they would want our Historic 10th Street Bridge project to continue.

Our goal is to make the 1130 foot Bridge useable from one end to the other by 2020, when it will be 100 years old. **Tamietti Construction has begun work on deck drainage and joint repairs.** We are pleased to announce grants from the Treacy Foundation, Erika Glazer Foundation, Town Pump and NorthWestern Energy for this work.

Liberty Electric is installing electricity to the deck of the Bridge for future events. We have received specific grants for this purpose from the Montana Cultural Trust and the Montana History Foundation.

We are now applying for grants to construct the actual trail on the Bridge. Your generous donations will be applied to this effort.
