Message from PCI President Arlyne Reichert:

May the Holiday Season bring peace to the World.

Please help reach our goal of a big celebration for the 100th Birthday of our Historic Tenth Street Bridge on August 20,2020! A necessary project is the installation of safety railings/balusters across the deck at an estimated cost of \$200,000. Since beginning the campaign to "Buy a Yard" of railing @ \$250, we've raised \$135,000 for 540 yards-just 260 yards yet to go. A generous local couple just issued a challenge to match your donation up to \$10,000.

Over the past two decades we've successfully repaired, protected and illuminated the Bridge's iconic arches, re-constructed a model arch to provide an attractive place to stage events, resealed the deck, connected the north end of the Bridge to River's Edge Trail & installed informational signage. Computer students at MSU-GF are organizing our database in preparation for installation of a permanent Donor Recognition Panel. Thanks to the considerable time & energy of our allvolunteer Board & the generosity of our donors, we have accomplished over a million dollars of restoration at no cost to local taxpayers.
